

## WEASEL NOTAM – 35FW-16-21 Misawa AB (MAB) Security Forces Blotter Distribution Policy 13 Jul 20



**PURPOSE:** To direct the 35th Security Forces Squadron Police Services in distribution of the Security Forces Blotter, IAW AFI 31-120.

**COMMANDER'S INTENT:** In order to protect the integrity of the base integrated security the Security Forces Blotter will only be distributed to those with a valid need to know, and not below the group level. Excerpts of the Security Forces Blotter (the Executive Summary) will be distributed to the unit commander level to facilitate squadron commander cross talk and trend analysis.

**BACKGROUND:** AFI 31-120 directs the Installation Commander to designate, in writing, and duty position or agency below the group commander level that should receive the Blotter. Information found within the blotter must be protected as FOUO, FOIA, Privacy Act Information, and Law Enforcement Sensitive. The Blotter will not be distributed beyond the designated recipients. This letter will be reviewed annually.

**IMPLEMENTATION:** Effective immediately, distribution of the Security Forces Blotter will be limited to the following:
