



MISAWA COVID-19 DIRECTIVE: WEEKLY HOT SPOT ANNEX



EFFECTIVE AS OF: 16 Jun 2021

Changes are highlighted in YELLOW

The stipulations below are IN CONJUNCTION with the “Misawa Air Base COVID-19 Directive.”

ON-BASE LIBERTIES

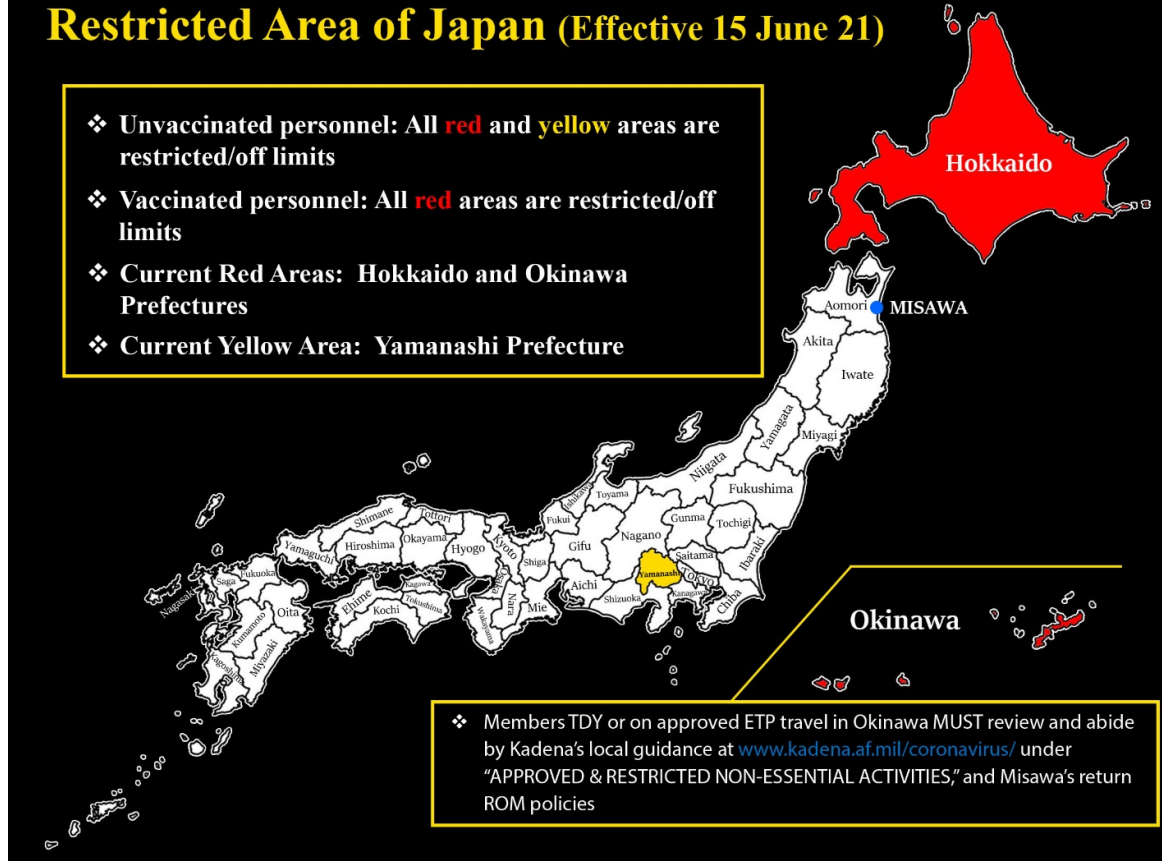
- Groups larger than 50 people that include people from outside of the Misawa AB community or indoor events that will exceed 50% of the meeting space capacity need approval from the coordinator’s unit commander

OFF-BASE LIBERTIES

- Maximum groups of 50 people or 50% of meeting space capacity, whichever is less, unless approved first O-6 or GS-15 in the coordinator’s chain of command, or 35 MSG/CC if no O-6 or GS-15 in your chain of command at Misawa AB
- Unvaccinated Misawa members are **AUTHORIZED** to visit locations that are not listed as restricted in the map, Vaccinated members may visit the restricted yellow areas but not red areas:
 - Off-base restaurants (subject to the following limitations):
 - If occupancy remains at 50% capacity or less of the maximum capacity for dining in the restaurant
 - Delivery and carry out are approved
 - Movie theaters/cinemas when the occupancy of the site does not exceed 50% and social distancing can be maintained
 - Tattoos shops, massage shops, and onsens
 - Off-installation gyms/fitness centers within Misawa City limits and facilities within close proximity of personal residence.
 - Amusement/theme parks **where COVID-19 mitigation measures are in place and maintained (social distancing and mask use enforcement).**
 - Travel to Yellow areas for **unvaccinated** personnel will require unit leadership approval and a 14-day ROM on return. (10-day Residential ROM followed by a 4-day Installation ROM)
- Misawa members are **RESTRICTED** from the following locations if **COVID-19 mitigation measures cannot be met or are not enforced**:
 - Festivals, flea markets, concerts, festivals, and events with high-density crowds or mass gatherings, or any facility with a potential for crowds, close contact, or closed spaces.
- Misawa members are **RESTRICTED** from the following at **ALL TIMES and LOCATIONS**:
 - Bars, nightclubs, karaoke clubs, and social clubs
 - EXCEPTION: Fully vaccinated members are allowed to visit bars, nightclubs, karaoke clubs, and social clubs within Misawa City if the location’s occupancy is not at greater than 50% capacity**

Restricted Area of Japan (Effective 15 June 21)

- ❖ Unvaccinated personnel: All red and yellow areas are restricted/off limits
- ❖ Vaccinated personnel: All red areas are restricted/off limits
- ❖ Current Red Areas: Hokkaido and Okinawa Prefectures
- ❖ Current Yellow Area: Yamanashi Prefecture



- ❖ Members TDY or on approved ETP travel in Okinawa MUST review and abide by Kadena’s local guidance at www.kadena.af.mil/coronavirus/ under “APPROVED & RESTRICTED NON-ESSENTIAL ACTIVITIES,” and Misawa’s return ROM policies
